Dear Parent(s)/Guardian(s):

Thank you for choosing Hampton University for your son/daughter's education. To assist you with understanding the requirements for our tuition and fees payments, we are providing the following information regarding your financial responsibilities. Please read this letter carefully and adhere to deadlines.

The **2024 fall semester tuition, room, board, and fees in the amount of \$22,950.00 (on-campus) or \$15,701.00 (off-campus) are due August 1, 2024.** Students who pre-register and submit payment(s) by **August 1, 2024** will receive a credit of \$100.00 against their fall tuition.

**Payment Methods include:**

- I. Pay 100% of the first-semester tuition, room, board, and fees by **August 1, 2024.**
- II. Pay balance less approved financial aid and scholarships for first-semester tuition, room, board and fees by **August 1, 2024.**
- III. Pay fees by participating in the **Full Service Payment Plan.** This plan will deduct your approved and awarded financial aid and scholarships from the total cost per semester and divide the remaining cost into four equal payments. The first will be due August 1, 2024 and three remaining payments will be due the 1<sup>st</sup> day of September, October and November of this year. **Additional information about this plan will be forthcoming in future communications.**
- IV. **Approved** and awarded financial aid and scholarships by **August 1, 2024** that covers the total cost of attendance (\$22,950.00 for on-campus or \$15,701.00 for off-campus) for the fall semester.
