DIRECTOR'S MESSAGE

To the Hampton University Pre-Law Institute Class of 2025:

Under the leadership of our 13th President LTG. (Ret.) Darrell K. Williams and First Lady Myra Williams, Hampton University is well into its next era of elevating our Standard of Excellence, producing the next generation of transformational servant-leaders, and above all—delivering the No. 1 student experience in America!

In my third year as its steward, the 2024-'25 academic year saw HUPLI achieve a number of historic "firsts": In August, during the first week of classes, HUPLI hosted the Court of Appeals of Virginia—for two days, our historic Ogden Hall was a state appellate courts house where our pre-law students witnessed the first ever (in the state of Virginia) panel of all black women judges preside over a full docket of appellate cases, hearing oral arguments from the opposing parties. By bringing court to our Home by the Sea, our pre-law students were the first at an HBCU (or any university without a law school) to have appellate proceedings occur on their campus. In October, HUPLI had the distinct pleasure of hosting the U.S. Court of Appeals for the Armed Forces. On this auspicious occasion, our pre-law students were privileged to witness our own distinguished alumna, the Hon. M. Tia Johnson, sit on the five-judge panel that heard oral arguments on an appeal from a military tribunal, as Ogden Hall was transformed into a United States Federal Appellate Court. These were just two of the events to which our pre-law students were privy this year. This year also saw a record number of law schools (22) visited campus to engage our pre-law students. Additionally, three national law firms—ProskauerRose, OgletreeDeakins, and BallardSpahral—visited campus to connect with our pre-law students and affirm their support of HUPLI. Most importantly, this past year saw our pre-law students, including a number of our graduates, experience tremendous success academically and via their co-curricular endeavors. Our pre-law students competed successfully in the Virginia Foundation of Independent Colleges' Applied Ethic Bowl, the HBCU National Speech & Debate Competition, and the Honda Campus All-Star Challenge. Finally, for the first time in recorded history, multiple senior pre-law students scored above the 98th percentile on the LSAT exam.

I will be forever grateful to the class of 2025 (and last year's class) for welcoming one of Hampton's sons back to this beloved institution. You embraced the programmatic changes and met the new challenges in the way we as Hamptonians do—you rose to the occasion! Again, I thank you for trusting me to help guide you on your academic and professional journey. I have every confidence that each of you are prepared and poised to realize your full potential whether in the noble profession of law or whatever field you decide to make your mark. Finally, know that your departure from your Home by the Sea is not "goodbye," as HUPLI is here to assist and support you as you take the next steps toward fulfilling your divine purpose. It is my sincere hope that you know that I love, respect and cherish you as young scholars and as future service-leaders.

It is my sincere hope that each and every member of HUPLI's Class of 2025 chases your wildest dreams while affirming and representing in all you do HUPLI's ethos:

After graduating Fordham Law School in 1997 Kenneth honed his skills as a litigator at the Brooklyn District Attorney's Office. As a prosecutor he worked in the red zone which covered high crime areas in the northern section of Brooklyn including East New York and Flatbush. He also worked in the sex crimes unit, the juvenile designated felony unit, grand jury and investigations, the complaint room, and the Violent Gang Bureau.

Upon leaving the Prosecutor's office in 2001, Kenneth formed his own law firm specializing in Criminal and Civil Rights litigation and some general litigation. Kenneth is also a founding member of both The Brooklyn Combine and Pixod. The Brooklyn Combine is a non-for-profit community organization that partners with schools, educators, other community organizations and dedicated city officials to help provide

critical education, mentoring, leadership, and social programs to youth and young adults in low-income and under-served communities. The Brooklyn Combine run academic and mentoring programs in the Brownsville and Red Hook sections of Brooklyn.

As a talented and well-respected criminal defense attorney in both Capital, Federal, and State court, in the past 21 years as a private attorney Kenneth has defended clients charged with everything including but not limited to federal capital murder, terrorism, murder, wire fraud, rape, RICO, drug conspiracy, etc. As a criminal defense attorney he has litigated over 100 criminal trials as both a prosecutor and defense attorney, securing over 50 not guilty verdicts as a defense attorney. Kenneth serves on both the EDNY and SDNY criminal panels and is also a federal capital murder attorney in both districts. Kenneth has also represented clients across the country who have been charged with the federal death penalty statute.

For the last 15 years Kenneth has been a professor at Fordham law in the trial advocacy department and most recently he has served as a professor in the Black Studies department at Brooklyn College. Kenneth also currently serves as a member of the federal death penalty working group in Washington D.C.

Having grown up in the Brownsville and Crown heights section of Brooklyn at a time where many of his peers were incarcerated or killed, the work that Kenneth is most proud of is not his impressive legal career, he is most proud of his work as a member of the Brooklyn Combine.

The Combine has provided him and his partners a number of paradigm shifting opportunities within the community. Some of those opportunities include working with students in the DOE as well as young people in the community. The programs are focused on changing the narrative and self-determination.

Kenneth's life work and journey is being a part of the work that facilitates necessary change in communities of color and the American legal system
