In addition to her role in the Office of General Counsel, Atty. Stevens serves as an adjunct faculty member at Hampton University. 2026 FACULTY HONOREE



NOVELLE JAMES OLIVER DICKENSON is a graduate of both Hampton University (B.A.) and Howard University (M.A.), focusing his studies of political science in American Government and Politics, Political Administration, Comparative Politics and Politics of Development. Over the course of his distinguished career, Professor Dickenson has served Hampton University in numerous instructional and leadership capacities that shaped generations of students and strengthened the Hampton University community.

Notably, Prof. Dickenson was the visionary of the comprehensive pre-law curriculum and he was the inaugural Pre-Law Advisor, working tirelessly to establish the foundation of the program we celebrate today. Prof. Dickenson saw the need to create an infrastructure to support and prepare Hampton University students who aspire to attend law school and enter the legal profession. To further these objectives he engaged law school admissions offices, the Law School Admissions Council (LSAC), and organizations such as the Thurgood Marshall Legal Fund, the Council on Legal Educational Opportunity (CLEO), just to name a few. Prof. Dickenson also secured travel grants to take students to law school recruiting activities as well as the LSAC Regional conferences. It was a usual occurrence for Prof. Dickenson or “Mr. D” as he was affectionately known to students and colleagues, to rent a van and drive students to events in cities such as Boston, Atlanta, and New York. Soon, law school admissions officers began making what became an annual “pilgrimage” to Hampton to court the “best and brightest” Hampton University students. Once the various pre-law activities began to take on organizational form when, what was the political science club, was renamed the political science and pre-law club. Soon, there was a need to hire a full-time faculty member also served as the university’s “Pre-Law Advisor.” The program continued to evolve as evidenced by the inauguration of the Phi Alpha Delta Law Fraternity chapter at Hampton University. The curriculum conceived by Prof. Dickenson and his student-centric focus became institutionalized and ultimately morphed into what is now known nationally as the **Hampton University Pre-Law Institute (HUPLI)**, which through its carefully curated, rigorous course offerings and other critical components, affords all Hampton University students a unique pathway to law school and the legal profession.

Beyond his vision, passion, and efforts to lay the foundation for HUPLI, Prof. Dickenson has demonstrated leadership in intercollegiate athletics serving as President of the Mid-Eastern Athletic Conference (MEAC) and as a member of the NCAA Academic/Eligibility and Compliance Cabinet. He is also dedicated to community involvement as he served as the first Vice President of the Hampton, VA branch of the NAACP. He is currently a member of Hampton’s Town and Gown Committee, and he serves as the President of the Delta Beta Lambda Chapter of the Alpha Phi Alpha Fraternity, Inc. Over more than four decades of service, Prof. Dickenson has built a distinguished legacy defined by academic excellence, leadership, and commitment to service at his Home by the Sea and beyond.

Today we recognize Prof. Dickenson’s foundational role in building what is now the Hampton University Pre-Law Institute with the **NOVELL DICKENSON LEADERSHIP AND SERVICE AWARD**. This award is presented to a graduating Pre-Law Scholar who exemplifies the ethos Professor Dickenson established — academic excellence, integrity, service, leadership, and a commitment to advancing justice through law.

THE HUPLI DIRECTOR'S AWARD

The HAMPTON UNIVERSITY PRE-LAW INSTITUTE DIRECTOR'S AWARD recognizes a Pre-Law Scholar who has demonstrated exceptional determination, growth, and commitment throughout their HUPLI experience. This award honors a Pre-Law Scholar who has overcome challenges, remained committed to growth, and embodied the spirit of perseverance through their journey toward the legal profession.



JORDAN HALL is the recipient of the **2026 HUPLI DIRECTOR'S AWARD**. Jordan is a graduating Senior, Political Science major with a Pre-Law Concentration from Sicklerville, NJ. Mr. Hall serves as a Golden Key Honor Society member, a Pre-Law Institute Ambassador, Peer Mentor, and President of Student Support

Services. In the summer of 2024 he was selected to participate in the George Mason Antonin Scalia Law School Immersion program. INEZ FIELDS, daughter of George Washington Fields, was a Hampton Institute graduate (c/o 1914) and attorney who broke racial and gender barriers in the legal field. After receiving her law degree from Boston University, she became one of the first African American women to be a second generation lawyer, and was

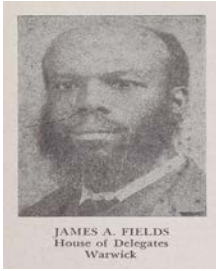
admitted to both the Massachusetts and Virginia state bars. Throughout her career she advocated for equal pay, voters' education, and civic engagement in her community. This award is named in her honor to celebrate her trailblazing contributions to the legal profession. The award goes to a graduating pre-law student who embodies academic excellence in her pursuit of being a trailblazer in the legal field.



REAGAN CARTER is the recipient of the **2026 INEZ FIELDS AWARD**. Reagan is a graduating senior Strategic Communications major with a Pre-Law Concentration from Alexandria, Virginia. As her time as a Hampton student comes to an end, she has firmly established herself as a dedicated student leader

for the university. She has maintained a 4.0 GPA throughout her time at Hampton and was recognized last school year at Honors Day with the Strategic Communications Department Award for having the highest GPA in the department. Her commitment to excellence extends beyond the classroom, as she currently serves as Vice President of the Senior Class, Fundraising Co-Chair of Women's Caucus, the 2025-2026 Miss Phi Beta Sigma and is a proud Spring 2026 Initiate into the Gamma Iota Chapter of Delta Sigma Theta Sorority, Incorporated. THE JAMES A. & GEORGE W. FIELDS ACADEMIC EXCELLENCE AWARD

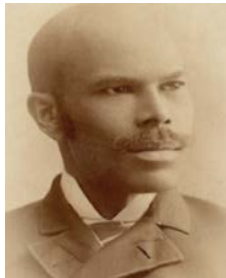


JAMES A. FIELDS and **GEORGE WASHINGTON FIELDS** were brothers born into slavery who became among the early generation of African American lawyers following the Civil War.

JAMES A. FIELDS was a graduate of Hampton Institute's inaugural class of 1871. He went on to study law at Howard University School of Law and became a prominent attorney in Hampton Roads as well

as an educator and member of the Virginia House of Delegates. By all available historical accounts, **JAMES A. FIELDS** was the first Hamptonian to pursue a law degree and enter the practice of law, thereby establishing what has become a long, unbroken tradition of Hampton University being an incubator for lawyers who continue to make their mark in the legal profession and in society at large.

GEORGE WASHINGTON FIELDS followed his older brother, graduating from Hampton Institute in 1878. He was part of Cornell University Law School's inaugural class, graduating in 1890 with the distinction of being Cornell Law School's first African-American graduate. He joined his older brother in private practice in Hampton Roads and became a leading lawyers with an expansive practice that served both black and white clients. This award is named in their honor to recognize their lasting legacy and to celebrate a student who reflects their commitment to academic excellence in pursuit of a career in the legal field.



NICHOLAS SUTTLES is the recipient of the 2026 J.A. & G.W. FIELDS AWARD. 2nd Lieutenant Nicholas Suttles, a native of Dalton, Georgia, is graduating with a Bachelor of Arts in Political Science and a minor in Army Military Leadership. He was accepted for an Educational Delay from the Army to attend law school this Fall. Throughout his time at Hampton



University, he has been an active member of the Hampton community, participating in SGA, Pi Sigma Alpha, Army ROTC, and The National Society of Pershing Rifles, Inc., all while maintaining a high GPA that earned him a spot on the Dean's List for multiple semesters.

THE NOVELLE DICKENSON LEADERSHIP & SERVICE AWARD

The **NOVELLE DICKENSON LEADERSHIP & SERVICE AWARD** is given to the graduating Pre-Law Scholar who exemplifies virtues of academic excellence, integrity, service, leadership established by Hampton University alumnus and longtime Professor, Novelle Dickenson. This year's recipient was selected by the Director of the Hampton University Pre-Law Institute and honors the continuation of Professor Dickenson's vision of preparing students for their success for law school and in the legal profession.



KE'MYA SUTTON is the recipient of the 2026 **NOVELLE DICKENSON LEADERSHIP & SERVICE AWARD**. Ke'Mya is a graduating senior, Psychology major with a Pre-Law Concentration from Elloree, South Carolina. She is a member of several organizations including Army ROTC, Phi Eta Sigma, The Freddie T. Davy Honors College, The Good

Girl Movement, Black Women in Law, Legal Minds, and Campus Curlz. During her time at Hampton University, she has received a 3-year scholarship from Army ROTC, a scholarship from Project Global Officer Language Immersion, and has been recognized for two departmental awards from the Department of Military Science and The Pre-law Institute. 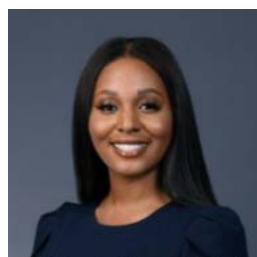

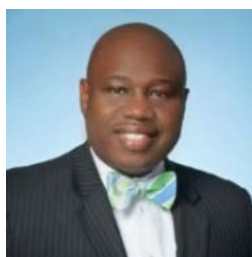

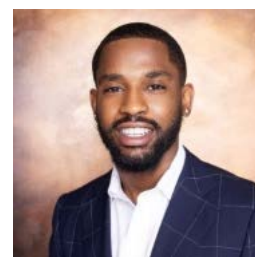
