Dear Dr. Taylor:

The Special Report for the M.Arch. program (168 semester credit hours) at Hampton University was reviewed during the October 18-19, 2024, meeting of the Board of Directors of the National Architectural Accrediting Board (NAAB).

The Board noted that the program did not submit sufficient evidence to demonstrate compliance with the following Conditions:

- **6.3 Access to Career Development Information**

The Board's review is included below:

**Condition 6.1 Statement on NAAB-Accredited Degrees**

The program must provide a link via the program's website to NAAB's statement on accredited degrees.

**Met.** *The program has provided sufficient evidence to demonstrate compliance with Condition 6.1.*

**Condition 6.3 Access to Career Development Information**

The program must provide a link via the program's website of career development information.

**Condition 6.4 Public Access to Accreditation Reports and Related Documents**

- The program must provide a link via the program's website of all Interim Progress Reports submitted since the last team visit.
- The program must provide a link via the program's website of the most recent decision letter from NAAB.
- The program must provide a link via the program's website of the Architecture Program Report submitted for the last visit.
- The program must provide a link via the program's website of the final edition of the most recent Visiting Team Report, including attachments and addenda.
- The program must provide a link via the program's website of the program's optional response to the Visiting Team Report, if applicable.
- The program must provide a link via the program's website of any Plan to Correct and NAAB responses to the Plan to Correct, if applicable.
- The program must provide a link via the program's website of statements and/or policies on learning and teaching culture.
- The program must provide a link via the program's website of statements and/or policies on diversity, equity, and inclusion.

**Met.** *The program has provided sufficient evidence to demonstrate compliance with Condition 6.4.*

**Condition 6.5 Admissions and Advising**

The program must provide a link via the program's website to documentation of the forms and a description of the process for evaluating the content of a non-accredited degree.

**Met.** *The program has provided sufficient evidence to demonstrate compliance with Condition 6.5.*

Based on the review of the Special Report, the NAAB directors voted to accept the Special Report, on the condition that **the program submits evidence of compliance with the remaining deficiency noted above by December 19, 2024.** If the documentation is not provided by the deadline or does not demonstrate compliance with the Condition, the program will not have satisfied the condition and accordingly will be required to submit a Plan to Correct by June 30, 2025.
