



**FACT SHEET
TRIO UPWARD BOUND PROGRAM
HAMPTON UNIVERSITY**

The Upward Bound Program, at Hampton University has served high school students since the 1960's. The program is designed to aid participants in transitioning and completing a post-secondary program of study after graduating high school. The participants must be enrolled in Newport News Public Schools in one of the following schools: Denbigh, Warwick, Heritage, or Achievable Dream High School. The participants must have a demonstrated academic and financial need and exemplify potentials for success in education beyond high school.

While in Upward Bound participants will be offered:

- Academic tutoring
- Advice and assistance in postsecondary course selection
- Preparation for successful completion of college entrance exams
- Information on federal Pell grant awards, loan forgiveness, and scholarships
- Assistance completing applications for federal student aid, as well as guidance with secondary school reentry
- Exposure to college tours and cultural enrichment activities, and more

In addition to these services, Upward Bound staff offers a six-week non-residential Summer Enrichment Academy for rising 9th-12th graders with an emphasis on increasing student achievement; and a non-credit Summer Bridge Program for our graduates with an emphasis on transitioning to college.

ELIGIBILITY: In order to qualify for initial acceptance to Hampton University's Upward Bound Program, the student must:

- **Meet the income eligibility criterion established by Federal Guidelines**
- **Be a potential first-generation college bound student (neither of whose parent (s) received a baccalaureate degree)**
- **Be a citizen or national of the United States**
- **Be at least 13 years old (and no more than 19 years old) and a rising 9th through 12th grader at the time of acceptance**
- **have a need for academic support in order to successfully pursue a program of study in education beyond high school.**
