We look forward to you returning to your Home by the Sea. To expedite your check-in process, you **MUST** be medically and financially cleared upon arrival. Please review the information below to assist you with the check-in process for Spring 2026.

### Check-In Schedule for Financial Clearance

- Students unable to obtain financial clearance by **January 5** must report to Whipple Barn according to the following days and times associated with the first letter of your Last Name:

### Clearance Status Check:

- Login to the HamptonU Experience located in the Quick Links tab on the Hampton University homepage.
- Navigate to the "View all cards" button on the right side of the screen and click on it.
- In the search bar on the left side of the screen enter "Registration dashboard" and press enter.
- Click on the "Registration Dashboard" card to open the registration portal.
- Click on "Prepare for Registration"
- Choose Spring 2026 Term from the drop-down menu
- If you have both notations in the light blue box below, then you are cleared to come to campus.
- Spring clearances are in process, so the current fall 2025 semester is being used in the example below:

## Non-Cleared Procedures:

- You must be medically and financially cleared to move-in to the residence halls
- If you are not medically cleared, you must contact the Health Center at [healthcenter@hamptonu.edu](mailto:healthcenter@hamptonu.edu) or 757-727-5315 for assistance.
- If you are not financially cleared, you must contact Student Business Services website at [home.hamptonu.edu/sbs/](http://home.hamptonu.edu/sbs/) for assistance.

## Financial Aid Acceptance Procedures:

Please be sure to check the Financial Aid portal via the HamptonU Experience for the 2025 - 2026 academic year.

For aid to disburse to your student account, you must Accept it using the Financial Aid portal in the HamptonU Experience. You will need your HU student ID# to access this information. Once you access the portal, complete the following steps.

- Access your account at: <https://sfp.ocs.oraclecloud.com/hampton/port>
- Click Take Action on Loans, Select Review/Accept Awards
- Select Amount Option or Decline Award for each fund offered
- Select Confirm and review your selections
- Click Done

Students who have been offered and will accept the Subsidized and/or Unsubsidized loans must log into [www.studentaid.gov](http://www.studentaid.gov) to complete the Master Promissory Note and Entrance Counseling. Parents who have been offered and will utilize the PLUS must log into [www.studentaid.gov](http://www.studentaid.gov) to complete the 2025 – 2026 PLUS loan application and Master Promissory Note using their Federal Student Aid (FSA) login information.

Please keep in mind that if you are offered an **endowed** scholarship, it is offered as a single year award. You are not guaranteed to be offered this funding from year to year.

### **Federal Work Study:**

### **HU ID Card Validation Process:**

Students who have been medically and financially cleared may obtain their current year stickers from the HU Traffic Office between the hours of 9 a.m. – 3:30 p.m. Monday through Friday. Proof of clearance (available electronically via HamptonU Experience) is required when obtaining current year stickers. Please complete this process by **January 16, 2026**.

### **Withdrawing from HU:**

**Students who are not planning to return to the University** must officially withdraw. Failure to officially withdraw will obligate you financially for the term. Please send an email to [withdrawals@hamptonu.edu](mailto:withdrawals@hamptonu.edu) to provide written notification of your intention not to return. Be sure to include your HU ID#.
